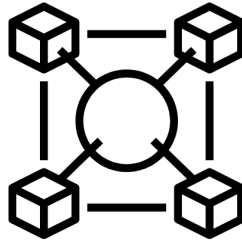
Reminders about the 2023 Medicare Promoting Interoperability Program Requirements



Participating eligible hospitals and CAHs need to meet the following requirements for CY

2023 to avoid a downward Medicare payment adjustment

- A minimum of any continuous 90 days for the electronic health record (EHR) reporting period.
- **New for CY 2023:** A requirement to use the [2015 Edition Cures Update](#) to meet the Certified EHR Technology (CEHRT) requirement.
- A minimum total score of **60 points**.
- Report **4 eQMs**, and the Safe Use of Opioids – Concurrent Prescribing eQM, using a full years' worth of data.
- Complete activities for the measures under the Protect Patient Health Information objective, including the Security Risk Analysis and attesting whether the annual self-assessment was completed on **all 9 SAFER guides**.

OKShine Update - Exemptions



The Oklahoma Health Care Authority Board has approved the proposed emergency rules to implement the statewide health information exchange.

These emergency rules will take effect immediately upon the approval and signature of Governor J. Kevin Stitt.

OHCA is thankful for the feedback of Oklahoma patients and providers in creating these emergency rules which encourages improved collaboration among different healthcare providers while protecting a patient's right to privacy. The new rules include:

- **Broad exemptions that allow any provider seeking an exemption to be granted one**
- Refined and added definitions;
- Clarification on required participation;
- Continued adherence to state and federal law regarding patient disclosure and consent;
- Defined fees, including participation fee, connection fee and grant funds to cover connection fees.

Access to Local Produce at Farmers Markets with OKFresh



OKFresh is a Produce Prescription Program that was originally funded through the Walmart Foundation, providing year-round fresh fruits and vegetables to eligible families in Lawton, Muskogee, Oklahoma City, and their surrounding areas.

By partnering with local healthcare providers, OKFresh identifies eligible individuals and provides an immediate solution for the provider to fill the gap for those living with food insecurity. In addition, the OKFresh program provides matching dollars to purchase up to \$40 worth of fresh produce each month from local farmers markets during the summer and at convenient locations in the service areas during the winter.

The Produce Prescription Program is now supported by Gus Schumacher Nutrition Incentive Program (GusNIP) and the USDA National Institute of Food and Agriculture. The program now operates in Lawton, Muskogee, and Miami. You can learn more about the current project [here](#).
