Governor Rejects Proposed Rule of Health Information Exchange



Oklahoma Gov. Kevin Stitt has rejected proposed administrative rule changes to establish a health information exchange in the state that the Oklahoma Health Care Authority approved in March, and the agency says it will work with the governor's office and lawmakers on the next steps for implementation. Under the legislation establishing the HIE, health care providers would be required to submit patient information to the exchange, which the OHCA says is protected by HIPAA.

HHS-OIG: Information Blocking Final Rule

On June 27, 2023, HHS-OIG posted its [final rule implementing information blocking penalties](#). The final rule establishes the statutory penalties created by the 21st Century Cures Act. If OIG determines that an individual or entity has committed information blocking, they may be subject up to a \$1 million penalty per violation.



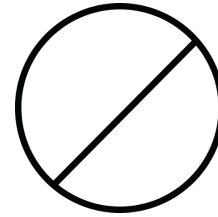
ENFORCEMENT

Enforcement of the information blocking penalties will begin September 1, 2023.



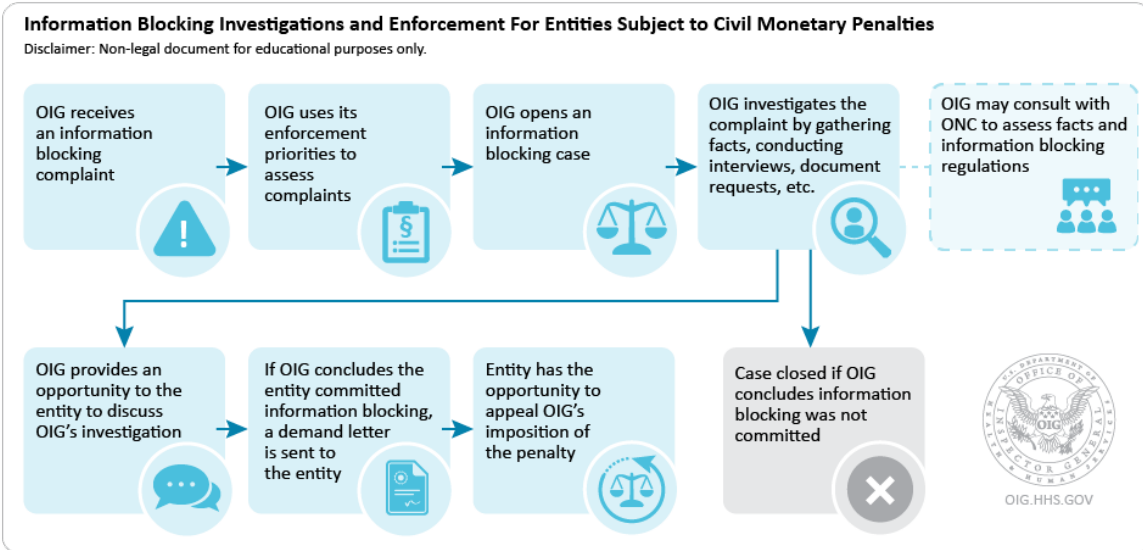
ENTITIES SUBJECT TO PENALTY

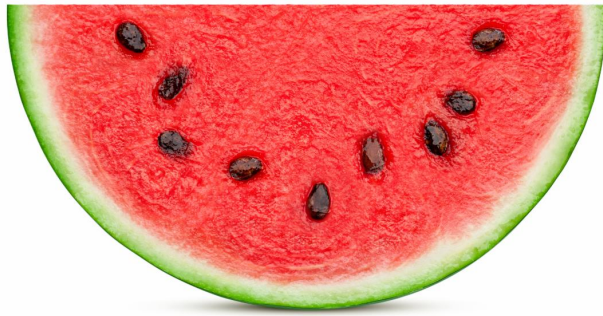
