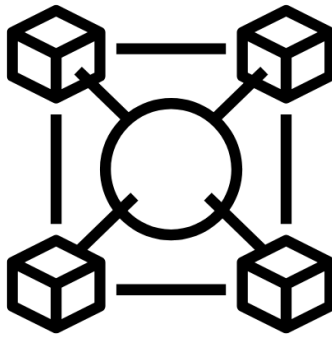

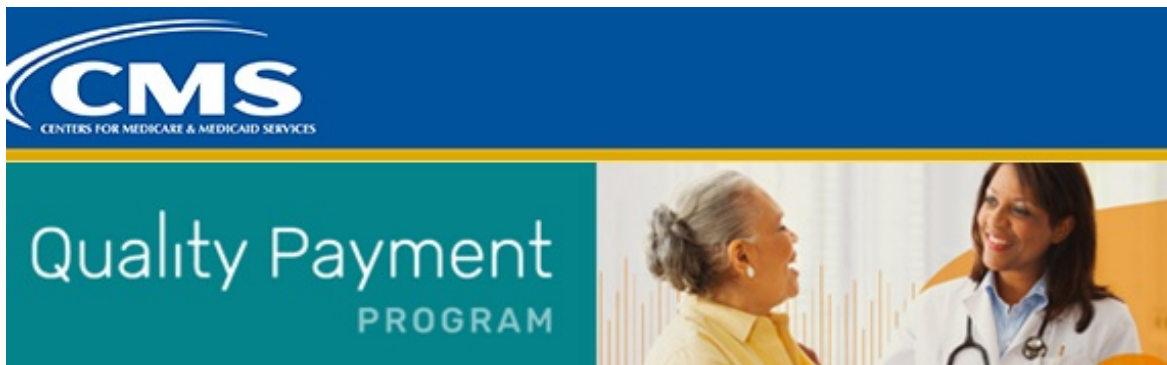

Important MIPS Updates



MIPS 2023 Data Submission is Now Open

(CMS) has opened data submission for Merit-based Incentive Payment System (MIPS) eligible clinicians who participated in the 2023 performance year of the Quality Payment Program (QPP). Data can be submitted and updated until 8:00 p.m. ET on April 1, 2024.

How to Submit and Review Your 2023 MIPS Data

Follow the steps outlined below to submit data:

1. Go to the [Quality Payment Program sign in page](#).
2. Sign in using your QPP access credentials.
3. Submit your MIPS data for the 2023 performance year or review the data reported on your behalf by a third party. (You can't correct errors with your data after the submission period, so it's important to make sure the data submitted on your behalf is accurate.)

2024 MIPS Payment Adjustments in Effect Based on 2022 Performance

2024 MIPS payment adjustments, based on each MIPS eligible clinician's 2022 MIPS final score, will be applied to payments made for Part B covered professional services payable under the Physician Fee Schedule from January 1 to December 31, 2024. Payment

adjustments are determined by the final score associated with a clinician's Taxpayer Identification Number (TIN)/National Provider Identifier (NPI) combination.

In 2023, each MIPS eligible clinician received a 2022 MIPS final score and associated payment adjustment factor(s) as part of their 2022 MIPS performance feedback, available on the [Quality Payment Program website](#).



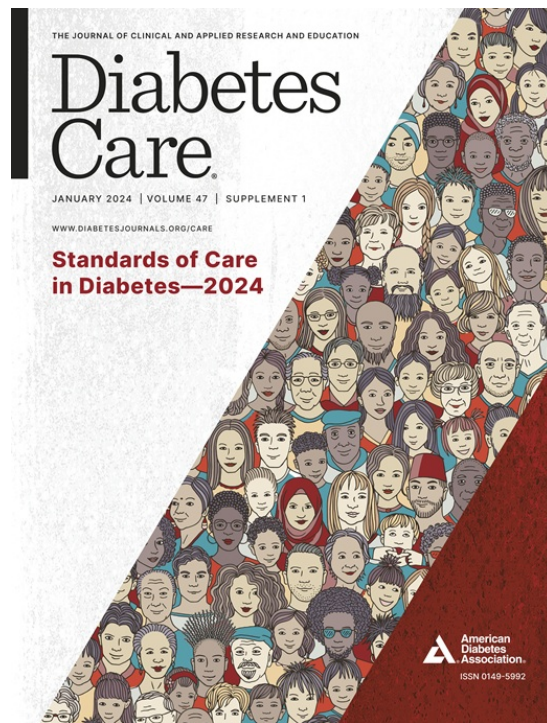

ADA Releases 2024 Standards of Care in Diabetes



The American Diabetes Association (ADA) "Standards of Care in Diabetes" includes the ADA's current clinical practice recommendations and is intended to provide the components of diabetes care, general treatment goals and guidelines, and tools to evaluate quality of care. Members of the ADA Professional Practice Committee, an interprofessional expert committee, are responsible for updating the Standards of Care annually, or more frequently as warranted.
