


What are RCORP and SCOPE-OK?

- The Rural Communities Opioid Response Program (**RCORP**) is a \$298 million, multi-year grant initiative supported by Health Resources and Services Administration (HRSA) to address barriers to access in rural communities related to substance use disorder (SUD), particularly Opioid Use Disorder (OUD)
- The Southcentral Consortium for Overdose Prevention and Education in Oklahoma (**SCOPE-OK**) will work to address barriers to the prevention, treatment, and recovery of opioid and other substance disorders.





SCOPE-OK Consortium



- SCOPE-OK meets the 2nd Month each quarter (February, May, August, November)—Ardmore Public Library 10 AM-12 PM
- Members include:
 - Groups focused on rural, preventative, and/or public health
 - Healthcare providers from all settings of care
 - Educators and school system representatives
 - Organizations involved with the prevention, treatment, and recovery of substance use
 - Persons directly impacted by substance use (persons in recovery, impacted family members, persons who use drugs, etc.)







She has her Bachelor's Degree and Law Degree from the University of Oklahoma and is an avid Sooner fan. Nearly 11 years of her legal and public service career was spent with the Oklahoma Department of Mental Health and Substance Abuse Services. There, she worked as an agency attorney, Advocate General, and spent her last two years as the Executive Director of the Oklahoma County Crisis & Urgent Recovery Center. Deneka and her family briefly left Oklahoma for her to oversee an acquisition and transition of a \$15 million-dollar non-profit behavioral health organization in North Carolina. Upon her return to Oklahoma, Deneka spent time as the Executive Director for Habitat for Humanity before returning to her work in public health. During her education and work in public service, she has been the recipient of various honors. She served as a Cortez Ewing Public Service Follow, Carl Albert Undergraduate Passarch Follow, and Cortez Ewing Public Service Fellow, Carl Albert Undergraduate Research Fellow, and was named Order of the Barristers in law school. What is the Overdose Response Strategy (ORS)?

The Overdose Response Strategy is an unprecedented and unique collaboration between public health and public safety, created to help local communities reduce drug overdoses and save lives by sharing timely data, pertinent intelligence and innovative strategies.

ORS Mission Statement

The mission of the Overdose Response Strategy is to help communities reduce fatal and non-fatal drug overdoses by connecting public health and public safety agencies, sharing information, and supporting evidence-based interventions.






HIDTA Overview

- Created by Congress in the Anti-Drug Abuse Act of 1988
- A program (not an agency) managed by the Office of National Drug Control Policy (ONDCP)
- Provides assistance to law enforcement agencies operating in areas determined to be critical drug-trafficking regions of the United States

HIDTA program goals:

- Disrupt the market for illegal drugs by dismantling and disrupting drug trafficking and/or money laundering organizations; and
- Improve the efficiency and effectiveness of HIDTA initiatives








▶ Unintentional Drug Overdose Deaths by Type of Drug, Oklahoma, 2012-2021






Unintentional Opioid Overdose Deaths by Drug, Oklahoma, 2012-2021






Number of Substances in OD Deaths

 More than 1/3rd of all unintentional fatal overdoses include more than one substance






Unintentional Drug Overdose Death Rates* by County of Residence**, Oklahoma, 2017-2021






Unintentional Methamphetamine Overdose Death Rates by County of Residence, Oklahoma, 2017-2021






Unintentional Fentanyl Overdose Death Rates by County of Residence, Oklahoma, 2017-2021






Unintentional Drug Overdose Death Rates by Age Group and Gender, Oklahoma, 2017-2021






Unintentional Drug Overdose Death Rates by Age Group and Race/Ethnicity, Oklahoma, 2017-2021






Unintentional Methamphetamine Overdose Death Rates by Age Group and Race/Ethnicity, Oklahoma, 2017-2021





Unintentional Opioid Overdose Death Rates by Age Group and Race/Ethnicity, Oklahoma, 2017-2021



Non-Fatal Overdoses (2021 still preliminary)


Most Common Substances Involved in Drug Overdose Hospitalizations by Year of Discharge, Oklahoma, 2017-2021*



- Women are more likely to survive an
- 4,230 Inpatient admissions for OD in 2021
- 5,605 ER admissions for OD in 2021
- 958 Unintentional OD Deaths in 2021



Preliminary Fatal Overdose Data for 2022



Preliminary 2022 Data

- Fentanyl OD rates outpaced Methamphetamine OD Rates for the first time.
- Fentanyl was involved in nearly 75% of opioid related OD fatalities in 2021. In years prior, it was 10-20%.
- While the fatal OD rate decreased by 68% between 2013-2019; it increased six-fold from 2019-2021


What is ODMAP?

ODMAP is a **free**, web-based tool that provides near real-time surveillance of suspected overdose events to support public safety and public health efforts to mobilize an immediate response to overdose events





ODMAP National Engagement



ODMAP has participating agencies in all 50 states, the District of Columbia, and Puerto Rico.



ODMAP Program Goals

- Provide near real-time surveillance of suspected overdose events
- Provide participating agencies with data to identify suspected overdose occurrences and spikes in near real-time
- Enable participating agencies to **develop effective strategies** for addressing overdose incidents occurring in their jurisdictions
- Enhance the development of regional strategies designed to prevent the spread of substance use disorders resulting in overdose incidents
